Letters from the Department of Agriculture.

A letter was read from the Department of Agriculture with reference to the forthcoming Show and Sale of bulls, stating that no bulls from the scheduled counties could be exhibited at the Show, and that Purchasers from these counties could obtain from the Department's representative a movement licence to permit any bull bought at the Show to be moved into a scheduled county provided that the farm to which the bull is to be brought was not within a 15 mile radius of an affected premises. They also had to request that a notice on the lines of the accompanying draft should be displayed in prominent positions in the sale rings and throughout the Show Yards, and that a copy of the notice should also be given to the Auctioneers with a request to read it before and during the progress of the Sale. (Noted).

Another letter was read from the Department of Agriculture acknowledging the resolution passed by the Society on the 15th February, relative to the prices to farmers for milk during the coming year, and stating the resolution had been noted.
