Special Joint Meeting of Show & Finance Committees:

Special Joint Meeting of Show & Finance Committees held on Saturday, July 30, 1949, Mr. E. J. Clarke (President) in the chair, also present Messrs P. J. O'Connell, M. D. Hosford, J. S. Henderson, J. Daly, H. R. O'V. S., E. Wally, M. A. O'Sullivan, C. Donovan, N. Hayes.

Work to be carried out at Show Grounds:

The President stated that the purpose of this Meeting was for the Committee to decide on the amount of work they would undertake by way of improvements or repairs at the Show Grounds during the months ahead. It was hoped to have the roof of the Box Alley completed by the end of this year, and the materials for this are already in stock. It would be necessary for the Committee to decide whether they would continue the wall of the Sheep Shed and the making of new stalls; also the erection of new Box Stalls. The Committee then visited the Show Grounds and examined the Cattle Shed, and made various suggestions regarding the layout of Box and Standing Stalls in this Shed, but agreed not to arrive at any decision until a later date.

Box Stalls:

The Committee then examined the Box Stalls in the Dog Yard, and agreed that these boxes are in such a bad state of repair, that it would be necessary to reconstruct them on the style of the Presentation Box Stalls, i.e., concrete front walls, with a three-quarter span roof. The Secretary was instructed to proceed with this work as early as possible.

Proposed reconstruction of Bars:

The proposed reconstruction of the Bar was examined, and it was decided that the Secretary should get a plan and submit same for future consideration by the Committee.
