Judges' reports, in connection with the recent Show were read.

Judges' Reports:

Re Trade Stands:

Col. S. White inquired if the rate charged for trade stands at the Show was commensurate with the amount of business at the Show, quoting - for example - a stand-holder, who had paid £21 for a trade stand and had a turnover of £4,000. In reply to this, the Chairman pointed out that the prices compared favourably with similar shows - there had been a 10% increase in 1951 and the Society were getting good exhibits, which were attracting many people to the Show.
